#### Issues for the RPCC to address

The most common themes were homelessness and crime. (About 30 comments)

- Monitor bird cherry tree poisoning project.
- Walking trail from Lovejoy thru Wendler parking lot to UAA, including addressing snow piles that block the current people trail in winter.
- New Council board may want to contact Scenic Foothills CC for council engagement and revitalization ideas. I have heard their meeting attendance has increased 300% (and not just when a controversial issue presents itself...)
- Partnering with Bounding CCs to work on "boundary community projects" for example, improvements in Eastchester Park/Playground
- Civic engagement
- We should seriously look at the future of Sitka Park. Crime & Safety clearly is the foremost area priority.
- Noise and light pollution (i. e. seasonal light displays) are problems that have gotten out of hand but which nobody is talking about.
- Painting Rogers Park elementary school, updating the school playground
- Work to implement a better community action plan to address neighbors being engaged with neighbors to assist with detouring crime and unsafe activity in in the neighborhood.
- Garbage, recycle and compost cans are in view from streets. SWS said that was not allowed when they implemented the automated pickup service. IT makes the neighborhood look trashy.
- Stop assembly from trying to destroy RP with new, unrequested zoning that are aimed at doing away with RP as we know it. And roll back all past changes. The city planning project did not include these zoning changes.
- homes with 'junk' yards, drug houses, abandoned homes
- More emphasis on dealing with the root of the homeless issue, not bandaids to NIMBY it.
- Keeping neighborhood single family; reduce property crime;
- Neighbors shoveling their sidewalks and stop parking on the sidewalks.
- The entire college village area All the streets and drainage to be updated this will eliminate the sinking streets
- Sound barrier along 36th, south side of College Village (ambulance route to Providence).
- City-wide, actually: any road work done by MOA or DOT should include re-surfacing of the bicycle/pedestrian ways. Some areas are impassable via bicycle.
