In advance of the Scenic Foothills meeting, here are several Vision Zero priorities that may be of most interest to your neighborhood:

- **36th Avenue** – long-standing community concerns about safe pedestrian access, particularly for children and caregivers near Scenic Park Elementary
- **Tudor Road and Muldoon Road** – both high-priority corridors under speed study, with speed feedback equipment already in place
- **Bragaw Street** – included in the Speed Management Study funded by the federal Safe Streets for All (SS4A) program
- **Neighborhood Greenways Program** – low-cost traffic calming measures on residential streets to reduce cut-through traffic and improve walking/biking conditions

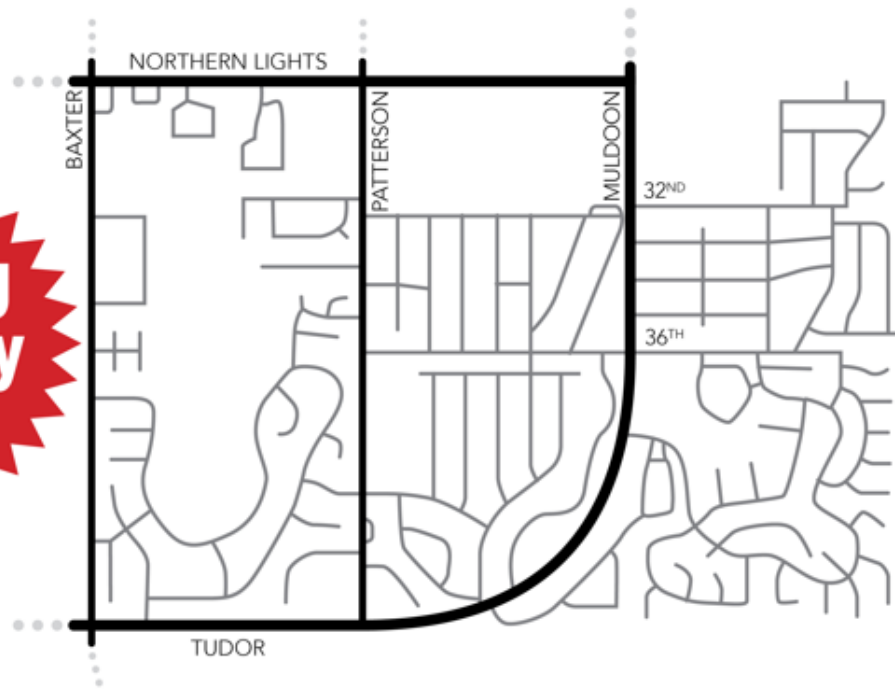
