



Alaska Department of Transportation & Public Facilities **AMATS: 'A' Street Resurfacing: Northern Lights Blvd to 6<sup>th</sup> Avenue** (Project No. 53481/STP-0527(21)



## PROJECT INFORMATION AND UPDATE

Lounsbury & Associates was selected to complete detailed design for these projects and wishes to provide an update on the status.

The Municipality of Anchorage Project Management & Engineering (PM&E) *C Street at 20<sup>th</sup> Avenue drainage project* (see yellow area) will correct problems discovered in the 1960s vintage stormwater system in the area. The outfall for the storm drainage system at Chester Creek is submerged at normal creek flows making routine cleaning operations virtually impossible. In addition, sediment is entering the storm drain from a variety of sources including broken pipes, damaged manholes, displaced or unsealed joints, corroded pipe sections, etc.

The *A Street Resurfacing* (see blue on map) is a straightforward Alaska Department of Transportation & Public Facilities (ADOT&PF) pavement preservation project that includes:

- Resurfacing A Street from curb to curb with restriping within the project limits;
- Correcting noncompliant Americans with Disability Act (ADA) facilities;
- Replacing permanent traffic recorders; railing at/near the Chester Creek Bridge and slope protection at 23<sup>rd</sup> Avenue overcrossing and
- Channelization improvements at the intersection of A Street and 16<sup>th</sup> Avenue will also be included in the A Street Resurfacing project.

The projects intersect near the storm drain outfall and considerable coordination resulted an agreement for DOT&PF to construct one of the new oil and grit separators and outfalls required for the storm drain improvements with its 'A' Street resurfacing project.

The A Street project is being separated into two phases due to right-ofway requirements. The first phase, from Northern Lights Blvd. to 9<sup>th</sup> Ave., is scheduled for construction in 2013. The second phase of the A Street Resurfacing project, from 9<sup>th</sup> Ave. to 6<sup>th</sup> Ave., is tentatively scheduled for construction in 2014. The MOA Project is also anticipated to be constructed in 2014. The team will directly contact all affected property owners about the construction.
