This noise permit is subject to the following conditions:

- 1. Sound from this event is limited to 70 dB(A) at the nearest residential property line.
- 2. If DHHS or APD receive founded complaints at any time during the course of the event, DHHS or APD may require reduction of noise levels or may otherwise modify or cancel permit.
- 3. If sound in an area occupied by event participants exceeds or is expected to exceed 90 dB(A), the permit holder must post a warning sign as required by AMC 15.70.B12 and shall make ear plugs available to the customers.
- 4. Hazardous noise emission standards in AMC 15.70.100 shall not be exceeded.

SPECIAL CONDITIONS

Permit covers Parade and Amplified Sound from Sound Stage in Delaney Park Strip

Parade hours 10 AM-1 PM - noise levels not to exceed 80 dBA at adjacent residential property during this time

Sound Stage hours from 12 PM - 6 PM - Noise not to exceed 70 dBA at nearest residential property during this time

Sound Stage speakers must be directed away from 10th Avenue residences

Sound levels must be monitored by qualified sound technicians to assure compliance with permit terms NON-COMPLIANCE WITH ANY TERM OR CONDITION OF THIS PERMIT WILL BE CAUSE FOR IMMEDIATE REVOCATION AND WILL SUBJECT PERMIT HOLDER TO THE APPLICABLE PROVISIONS OF AMC 15.70. A COPY OF THIS PERMIT MUST BE ON SITE AND BE AVAILABLE UPON REQUEST.
