This noise permit is subject to the following conditions:

- 1. Sound from this event is limited to 70 dB(A) at the nearest residential property line.
- 2. If DHHS or APD receive founded complaints at any time during the course of the event, DHHS or APD may require reduction of noise levels or may otherwise modify or cancel permit.
- 3. If sound in an area occupied by event participants exceeds or is expected to exceed 90 dB(A), the permit holder must post a warning sign as required by AMC 15.70.B12 and shall make ear plugs available to the customers.
- 4. Hazardous noise emission standards in AMC 15.70.100 shall not be exceeded.

Event setup at 7 AM - no amplified sound prior to 8 AM Noise permit valid from 8 AM - 4 PM Noise is not to exceed 70 dBA at the nearest residential property line; applicant must have qualified individual conducting monitoring to assure control of noise levels.

PA speakers to face away from residents on 10th Avenue. Generators must have noise shroud and sound dampening or be placed on 9th Avenue side of Park Strip
