Road Board: Bob Gill gave an update. Per Bob Gill, there is no new letter from the Road Board re: Yosemite Drive.

Joe Vicente has requested MOA to meet with Eagle Pointe home owners Association regarding Yosemite Drive drainage and upgrades and city has not addressed these issues.

Topics on Yosemite Drive per Bob Gill:

1. federal funding: DOT to get information to John Rodda soon
2. DOT funds: for turn lane coming off Yosemite Drive
3. Trail connection from Veterans Parkway to connect to Yosemite Drive
4. \$135,000 to 300,000 for drainage issue

\$1.1 million dollars has been allotted for site improvements for Eagle River area.

Update by Bill Starr: Bill Starr reports that Mental Health Trust has a preliminary plan for land at corner of Yosemite Drive and Eagle Rive Loop Road for 62-70 residential homes and small commercial development.

Tim Potter and Allison from Mental Health Trust will attend May SFCC meeting to further discuss development in this area.

There are some talks with Salvation Army and Mental Health Trust for Clithroe campus to be relocated by Hiland Women's Prison

The Knik Arm Crossing is still up in the arm. The Glenn Highway lighting has been approved to South Birchwood. There will be a Town Hall meeting no 3/17/07 from 1600 to 1800.

Road Board: continued update by Bob Gill. Mill rate is 1.85-1.91. The number one priority for Road Board is Monte Drive and Old Glenn Highway intersection—a lot of accidents happen at this location. Mail thefts in upper Hiland Road Valley—need more locked boxes and this issue will be discussed at next Road Board meeting. There have been mail thefts on Birdsong Drive. Most of the cost will be paid by Road Board and contribution by SFCC members in area will be around \$100. Joe Vicente reports MOA to lower mil rate by .21 for street lights.

CAC update: update given by Andrew Brewer. CAC has no contract authority and is not a legal authority. CAC will ask Assembly for authorization to proceed with their tasks. April, 2007 is good time to reaffirm request for CAC. They will formally present their request after April election. Bobbi Wells will contact state of Alaska for more funds. Federation of Community Councils would be administrator of grant. FCC to clarify language to continue monitoring funding for separate chapter.

Next CAC meeting is on 3/7/07.

Anchorage Tomorrow: Matt from their organization gave a short presentation on Propositions 2-6 and gave handouts to SFCC members. He encouraged all SFCC members to vote for Propositions 2-6.
