Task Force to Reimagine Public Safety Advisory Commission - Phase 2

The Mayor's Office and Anchorage Community Development Authority will host an information session for community members to learn more about the Municipality's Microunits for Recovery Residences pilot project. The information session will take place Tuesday, September 30th, 6 p.m. to 7:30 p.m. at St. Mary's Episcopal Church, 2222 E. Tudor Rd., Anchorage, AK 99507. The project includes at least 24 microunits constructed this fall and located on municipal land near the Elmore Permit Center. These Recovery Residences will help address Anchorage's need for transitional housing for people experiencing homelessness who are seeking treatment for substance use disorder.

The Air Force Base Realignment and Closure (BRAC) program is currently assessing whether there is enough community interest to establish a Restoration Advisory Board (RAB) at the former Kulis Air National Guard Base (ANGB). A RAB is a local stakeholder group that includes government entities, local businesses, and concerned citizens. It meets regularly to discuss environmental cleanup activities occurring on an active or former military installation, such as the former Kulis ANGB.
